JUDGMENT

Antony Dominic, J.

This appeal is filed by the defendant in O.S.141/11 on the file of the Sub Court, Ernakulam challenging the judgment and decree dated 19.9.2012. By order dated 5.10.2015, this appeal was referred for mediation.
