O R D E R

This review petition has been filed by the petitioners to seek a correction of the cause title of the writ petition, so as to insert the name and address of the correct respondents against whom directions had to be issued. It is pointed out that in the writ petition, the authority to whom the direction was to be issued was wrongly shown as the District Supply Officer, Thrissur instead of the District Supply Officer, Kozhikode and District Supply Officer, Malappuram. It is pointed out that inasmuch as the writ petition was disposed by judgment dated 6.1.2015, a correction in the cause title of the writ petition can be effected only if the said judgment is first recalled. Taking note of the submission of counsel for the review petitioners, and to enable them to effect the correction in the cause title in the writ petition, the judgment dated 6.1.2015 is recalled, and the writ petition is posted after ten days.
