Antony Dominic, J.

This is an application filed to condone the delay of 272 days in filing this revision petition.

2. We heard the counsel for the petitioners and the learned Government Pleader appearing for the official respondents.

3. Reading of the affidavit itself shows that there is no satisfactory explanation for the long and inordinate delay. Even otherwise, the averments in the affidavit itself would disclose that the attempt of the petitioners is to get a rehearing of the writ appeal, which is also impermissible. For these reasons, we are not inclined to condone the delay. Delay petition is dismissed.

Consequently, the review petition is also dismissed.
