ORDER

Ramachandran Nair, J.

The review petition is filed seeking to correct the amount shown as Rs.9 Lakhs in paragraph 9 as Rs.12 Lakhs, paid as security.

2. It is pointed out that the figure noted in paragraph 9 of the judgment as Rs.9 Lakhs, is a mistake and has to be corrected as Rs.12 Lakhs. The case of the review petitioners is that they have paid an amount of Rs.12 Lakhs as security to the landlord.

2. We allow the correction, but the same will not be treated as a finding by this Court as regards the correctness of the total amount, if any, received by the landlord as security deposit.

The Review Petition is accordingly disposed of. No costs.
