When the review petition came up for hearing today, counsel for the 6th respondent in the review petition who is the petitioner in the writ petition submitted that he has no objection in allowing the application for review as due to the change of circumstance, he does not want any police protection and the writ petition can be dismissed as not pressed leaving open the right of the parties to agitate the case before the civil suit pending.
