J U D G M E N T

This Second Appeal arises from a suit for injunction. The suit was decreed by the trial court and the decision of the trial court has been confirmed in appeal. Defendants 1 and 2 who are aggrieved by the decisions of the courts below have preferred the appeal.

2. In this Second Appeal, the first respondent/plaintiff has filed I.A.No.2261 of 2015 stating that they have settled their disputes with defendants 1 and 2 and praying to dismiss the suit as withdrawn.

In the light of I.A.No.2261 of 2015 filed by the plaintiff, the judgments impugned in the Second Appeal are
