JUDGMENT

Antony Dominic, J.

This appeal is filed by the Respondents in W.P.(C) No.15525 of 2010. The judgment under appeal shows that the learned Single Judge had disposed of the writ petition following the principles laid down by this Court in '**P.K. High School v. State of Kerala**' [2011 (4) KLT 365]. The State had preferred W.A.No.1267 of 2012 against the judgment in '**P.K. High School's** case (*supra*). That writ appeal was entertained and the judgment of the learned Single Judge was stayed. Subsequently, the writ appeal was dismissed by judgment rendered on 11.02.2014.

2. In view of the above, since the issue raised in this appeal is covered by the Division Bench judgment in W.A.No.1267 of 2012, this appeal is only to be dismissed and we do so.
