ORDER

The petitioner is seeking the transfer of OP No.712/2014 pending before the Family Court, Alappuzha to the Family Court, Ernakulam where OP 73/2015 and MC 12/2015 filed by the petitioner, are pending.

2. The petitioner is the wife and the respondent is the husband. OP 73/2015 has been filed by the petitioner before the Family Court, Ernakulam for recovery of her gold ornaments, money etc. MC 12/2015 is filed by the petitioner for getting maintenance to her as well as her child. The respondent has filed OP 712/2014 before the Family Court, Alappuzha seeking restitution of conjugal rights.
