JUDGMENT

This writ petition is filed by the petitioner, who is a resident of Chithrapuzha in Ernakulam District seeking a writ of mandamus commanding the 2nd respondent to consider Ext.P1 representation against the permission granted to the 3rd respondent to erect a mobile tower in building No.3/593 in Ward No.13 between Chithrapuzha bus stop and Kurishupally near Refinery Road. The petitioner has also sought for various other reliefs.
