ORDER

Petitioner is the wife of the respondent. The respondent has filed O.P.No.1317 of 2015 against her in Family Court, Ernakulam. But she has filed O.P.No.622 of 2015 and M.C.No.142 of 2015 against him in Family Court, Irinjalakuda. Her prayer is to transfer the proceedings from Family Court, Ernakulam to Family Court, Irinjalakuda.

2. Heard.

3. The facts of the case indicate that all the cases should be enquired into by the same court. Two proceedings are pending in Family Court, Irinjalakuda. The petitioner who is aged only 22, resides near Irinjalakuda court. The respondent resides at Aluva, which is not very far away from Irinjalakuda. So I am inclined to grant the prayer of the petitioner.

In the result, this transfer petition is allowed. OP.No.1317 of 2015 of Family Court, Ernakulam is
