This appeal is filed against the judgment of the learned Single Judge in W.P.(C)No.38097/07. The fact that the issue raised is fully covered in favour of the respondent by a Division Bench judgment in ***Sreelekha v. Manoj (2012 (3) KLT 54)*** is undisputed.
