The wife is the petitioner and husband is the respondent. Tr.P.(C) No.450/2014 is filed seeking a transfer of O.P.No.718/2014 filed by the respondent before the Family Court, Thrissur to the Family Court, Irinjalakuda. O.P.No.684/2014 and M.C.169/2014 filed by the petitioner against the respondent are pending before the Family Court, Irinjalakuda. O.P.No.684/2014 is for the recovery of money, gold ornaments, etc. and M.C.169/2014 is one claiming maintenance. Tr.P.(C) No.451/2014 is filed by the petitioner seeking transfer of O.P.(G&W) No.987/2014 filed by the respondent before the Family Court, Thrissur to the Family Court, Irinjalakuda where the other matters are pending.

2. O.P.No.718/2014 is filed by the respondent seeking restitution of conjugal rights. O.P.(G&W) No.987/2014 is filed by the respondent seeking the custody of the minor children. The

children are presently residing with the petitioner within the jurisdiction of the Family Court, Irinjalakuda.
