Ramachandran Nair, J.

Heard both sides. The prayer is to withdraw A.S.No.131/2012 pending before the 2nd Additional District Court, Palakkad to be heard along with R.F.A.Nos.692/2012 and 742/2012.

2. The learned counsel for the respondent submitted that there is no objection for withdrawing the said appeal. It is seen from the judgment -Annexure 1 that O.S.Nos.162/2006, 31/2007 and 185/2007 were disposed of by a common judgment.
