Notice declared duly served.

2. This is a petition filed under Section 24 of C.P.C. seeking transfer of O.P.No.699/2013 pending before the Family Court, Kollam to Family Court, Chavara.

3. Suffice to say that the marital relationship between the petitioner and the respondent ran into rough weather and both instituted proceedings against each other. It is pointed out by the petitioner that initially she has filed M.C.No. 177/2012 before the Family Court, Kottarakkara for maintenance which was later transferred to Family Court, Chavara due to administrative reasons.
