The petitioners herein are the petitioners in M.C 196/2010 of the Family Court, Thiruvalla. They seek transfer of the case to the Family Court Pathanamthitta on the ground that all the other connected matters are now pending before the Family Court, Pathanamthitta, and transfer of the case to Pathanamthitta will not cause any inconvenience or hardship to the respondent. The respondent remained absent in the proceeding in spite of notice.
