JUDGMENT

Antony Dominic, J.

This appeal is filed by respondents 1 to 4 in W.P.(C) No.3255 of 2014, challenging the judgment dated 13.8.2014 of the learned single Judge. Having heard the learned Government Pleader and also the learned counsel appearing for the respondents, we find that the issues raised in this appeal are fully covered against the appellants by virtue of the judgments of this Court in **Moosakutty Vs. District Educational Officer, Wandoor** (2009 (3) KLT 863) and **Nadheera Vs. State of Kerala** (2011 (3) KLT 790). Further Exts.R1(a) and R1 (b) produced along with counter to C.M.Appn.No.714 of 2015 shows that similar benefit has already been extended by the Government to similarly situated persons.

For all these reasons there is no merit in this appeal. The writ appeal is dismissed.
