1. The captioned interlocutory application is filed seeking leave to withdraw the writ appeal and thereby to preserve the order impugned in the appeal, which is an interlocutory order passed on 23.06.2014 in WP(C) No.15471 of 2014. This writ appeal has not been admitted.

Taking into consideration the factors pointed out, we grant leave to withdraw this writ appeal without prejudice to the appellant pursuing the matter before the Scrutiny Committee in terms of the aforementioned interlocutory order dated 23.06.2014; however clarifying that if such proceedings have already concluded, they shall not be re-opened merely on the basis of this judgment.
