JUDGMENT

Ashok Bhushan, C.J.

This writ appeal has been filed against an interim order dated 03.09.2015 in W.P.(C) No.26648 of 2015 by which the learned Single Judge has permitted the petitioners to participate in the Volleyball Championship proposed to be conducted on 06.09.2015. The Kerala State Volleyball Association and others came up with this appeal against the said interim order.

2. It is submitted that the Championship which was scheduled to be conducted on 06.09.2015 was postponed to 16.09.2015. But even on 16.09.2015 no one came to participate as per the interim order dated 03.09.2015. He submits that the interim order has already out lived its purpose and hence the writ appeal be closed with the aforesaid observation.

Recording the aforesaid statement, we close the Writ Appeal.
