JUDGMENT

Petitioner is the Manager of Kuruveli Vishnu Sharma Lower Primary School, Kuruveli. Petitioner submits that school building is situated in a plot having an extent of 2½ acres. Petitioner further submits that one acre of land is remain unutilized and he wants to be dispose of the same. Therefore petitioner approached the second respondent by Ext.P2 request. Petitioner approached this Court for early disposal of Ext.P2.

2. Learned Government Pleader points out at Ext.P8 and submits that the petitioner has been directed to produce certain records.
