J U D G M E N T

The petitioners' team participated in the event **-Sangha Nrutham'**, in the Ernakulam District School Kalolsavam 2014-15. The petitioners' team came to be sidelined, when the result was published, as a result of which they are not in a position to participate in the State Level Competition. Eventhough they filed an appeal, it came to be rejected. The main ground of challenge is that the stage was not convenient for performing the event and that the carpet was slippery .

2. The learned Government Pleader, on instruction submits that there is no pith or substance in the contentions raised. There is a difference of '**27**' marks between the petitioners' team and the first price winner's team. It is added that the petitioners' team could achieve only the 5th position.

3. After going through the pleadings and proceedings, and also the contents of Ext.P8 order of the appeal Committee , this Court finds that the petitioners have not established any tenable

ground to call for interference. Accordingly, interference is declined and the writ petition is dismissed.
