Heard the learned counsel for the petitioner.

2. By this Writ Petition, the petitioner has prayed for a direction commanding respondents 1 and 2 to afford effective and adequate police protection to the petitioner to protect the property in the light of Ext. P1 order against any trespass. Ext.P1 is an order of interim injunction granted by the learned Munsiff in Suit No. 618 of 2014.

3. Petitioner having already filed a suit in the Civil Court

and obtained an interim injunction, we see no reason to entertain the Writ Petition. Petitioner may take such steps in the civil court as permissible under law including the proceedings for violation of the interim injunction order, if any.

With the above observation, this Writ Petition is closed.
