The petitioners have approached this Court seeking for police protection in the matter relating to civil construction being done by them in 17 cents of property at Attipra Village. The allegation was that respondents 4 to 7 were creating obstruction in the work being done by them. An interim order had already been granted by this Court on 17.1.2014 directing the police to ensure that no law and order situation arises in the construction activities being done by the petitioners.

2. Learned Government Pleader submits that after the interim order, no untoward incident has been reported.

Hence, we close the writ petition with liberty to the petitioners to approach the police, if there is any further cause of action.
