JUDGMENT

The contention of the petitioner primarily is three fold and they are as under:

(i) Ineligible persons continue in the Administrative Committee of the second respondent bank.

(ii) Steps are afoot to enhance the share amount and paid up the share capital illegally by the Administrative Committee.

(iii) No steps are taken for conducting the election to the Managing Committee of the second respondent bank.

2. The petitioner has in this regard submitted Ext.P5 representation to the first respondent. I direct the first respondent to issue notice to the petitioner as well as to respondents 2 to 6. Final orders on Ext.P5 representation shall be passed within a period of one month.

The Writ Petition is disposed of.
