JUDGMENT

Ext. P2 order inter alia deals with the formation of a new electrical section at Koodaranji by bifurcating Thiruvampady electrical section. The writ petition has been filed seeking implementation of Ext. P2 order in the matter of formation after bifurcation. There is already a direction in W.P.(C). No. 954/2014 to direct the Kerala State Electricity Board to take a decision in the matter as regards the implementation.

2. The Standing Counsel on instructions submits that a final decision will be taken soon. Time is sought till 31.07.2015 to take a final decision as regards the implementation. I record the said submission making it clear that the decision taken will be duly communicated to the parties.
