Exts. P2 and P3 details of the attendance of the petitioner show that he has put in more than 10 years of service as on the date of Ext. P4 Government Order. There is no reason as to why the services of the petitioner shall not be regularised in the light of **Suresh Kumar v. State of Kerala [2013(2) KLT 258]** and other cases.

2. Ext. P7 order is accordingly quashed and the respondents are directed to regularise the services of the petitioner in the post of conductor within a period of two months.
