2. Whether the petitioners are contract employees or entitled to be regularised in service are matters to be considered by the Managing Director of the third respondent.

3. I direct the third respondent to forward Exts.P11 to P13 representations to the Managing Director of the third respondent Society. The Managing Director shall consider the representations after due notice to the petitioners and take a decision therein. Every endeavour shall be made to pass final orders thereon within a period of one month.
