The penalty can be on the basis of fixed charges as well as current charges. The issue is concluded by **Executive Engineer, Southern Electricity Supply Company of Orissa Limited (SOUTHCO) and Another v. Sri. Seetaram Rice Mill [(2012) 2 SCC 108]**. Ext. P7 order imposing penalty cannot therefore be faulted with.
