JUDGMENT

The petitioner intends to challenge Ext.P4 order by filing an appeal under Section 126 of the Electricity Act, 2003. It is mandatory that one half of the amount assessed thereunder should be deposited in order to maintain the appeal.

2. Electricity connection to the premises of the petitioner shall be restored on his depositing one half of the amount assessed. The restoration of electricity connection shall be done soon on making the statutory deposit and the appeal shall be preferred by the petitioner within a period of two weeks. The electricity connection is liable to be snapped in case the petitioner fails to make the statutory deposit and also fails to file the appeal within the time stipulated.

The Writ Petition is disposed of.
