JUDGMENT

The petitioner had filed the above writ petition for directing issuance of Pay Slip or authorisation to the petitioner to enable her to draw salary, including the annual grade pay, attached to the post of Associate Professor and arrears of pay as per the UGC Scheme, 2006.

2. An interim order was passed on 29.03.2011, wherein the University's statement that a decision has been taken that UG Service (non PG service) cannot be counted for Career Advancement Promotion to Associate Professors, was taken note of. The service, according to the University, can be reckoned only up to Career Advancement Promotion to Associate Professor (senior scale). The University was also said to be in the process of issuing such individual orders. The petitioners then submitted

that they were proposing to challenge the adverse orders and merely sought for disbursing admissible amounts.

2. The learned counsel for the petitioner submits that the entire amounts have now been paid. However, that is not by virtue of the interim order. Going by the interim order, the petitioner would have to challenge the adverse orders, if any, passed against her.

Subject to such challenge, the writ petition would stand closed. No costs.
