JUDGMENT

The petitioner participated in the event 'Mappilappattu' in the District Level School Kalolsavam and could secure only the 12th position. The appeal was rejected by the Appeal Committee as per Ext.P4 order allegedly without considering the contention that the performance was affected by the mike problem and hence the writ petition.

2. The learned Government Pleader submits on instructions that, there is no pith of substance in the contentions raised. The 1st prize winner got 245 marks where as the petitioner could secure only 213 marks, thus there is a difference of 32 marks. The allegation, with regard to the mike problem is wrong and that it was applicable to all participants. Further, there was no such report from the stage manager.

3. After going through the pleadings and proceedings and the submissions of the learned Government Pleader, this Court finds that the petitioner has not established any tenable ground to call for interference. Accordingly, interference is declined and the writ petition is dismissed.
