JUDGMENT

Shaffique, J

This writ petition has been filed seeking police protection alleging that threat was caused by respondents 4 to 11. An interim order has been passed by this Court on 16.1.2014 directing the police to provide necessary protection to the petitioner.

2. Counter affidavit has been filed by respondents 4 to 11 inter alia contending that petitioner's brother is involved in several crimes against respondents and he is a rowdy who is continuously harassing daughter of the seventh respondent when she goes to college.

3. Learned Government Pleader submits that after the interim order has been passed in the writ petition, no untoward incident has been reported.

4. It appears that there was some conflict between the petitioner and the family members of the respondents 4 to 7.

Having regard to the fact that no untoward incident has been reported during the pendency of the writ petition, we close the writ petition with a direction to the police to ensure maintenance of law and order.
