JUDGMENT

The petitioners' team participated in the event 'Thiruvathirakali' in the District Level School Kalolsavam and could secure only the 8th place. The appeal was rejected by the Appeal Committee as per Ext.P5 order allegedly without considering the contention that the judges were not qualified and judging was not proper. There is also a contention that, the 1st prize winners were given more time to perform and hence the writ petition.

2. The learned Government Pleader submits on instructions that, there is no pith of substance in the contentions raised. All the judges were qualified. The time sheet produced by the stage manager was verified and nothing as alleged was found out.

3. After going through the pleadings and proceedings and the submissions of the learned Government Pleader, this Court finds that the petitioners have not established any tenable ground to call for interference. Accordingly, interference is declined and the writ petition is dismissed.
