JUDGMENT

The petitioners were participants in 'Group dance' competition held recently in the Malappuram Revenue District School Kalolsavam. Despite the best performance stated as put in by the petitioners' team, they were sidelined. The first prize was awarded to some other team, who according to the petitioners had not put in any such deserving performance. In spite of filing appeal against the decision of the Judges, it came to be rejected as borne by Ext. P2, which made the petitioners to approach this Court by filing the present writ petition.

2. Heard the learned Government Pleader as well, who submits that there is absolutely no pith or substance in the averments raised in the writ petition. It is stated that the Judges who evaluated performance were experts in the field. It is pointed out that the appeal preferred by the second prize winner stands dismissed and there is a margin of 23 marks between the petitioners' team and the 1st prize winners.
