Petitioner has been appointed as Training School Assistant (Malayalam) in the 2nd respondent Institute. The approval of appointment has been declined by the District Education Officer and the Deputy Director of Education as per Exts.P2 and P3 orders. Challenging these orders, petitioner preferred Ext.P4, revision before the 1st respondent. Petitioner approached this Court on account of non consideration of Ext.P4 by the first respondent.

In view of pendency of Ext.P4 revision, there shall be a direction to the first respondent to take appropriate decision on Ext.P4 after affording an opportunity of hearing to the petitioner and the third respondent-Manager within a period of three months from the date of receipt of a copy of this judgment.
