JUDGMENT

The Non Joining Duty vacancies were reported by the first respondent bank only on 18.11.2014 as evident by Ext.P4 proceedings. But the ranked list for the post of Clerk/Cashier in the first respondent bank had expired on 30.06.2014 itself. No advise could be made from such a list even in respect of Non Joining Duty vacancies as has been held in **Kerala Public Service Commission Vs. Sheeja [2013 (1) KLT 197 (SC)]**. No purpose would be served by directing the second respondent to consider Ext.P5 representation put in by the petitioner in the circumstances.

The Writ Petition is dismissed.
