The selection process was interdicted in W.P. (C) Nos.15676/2013 and 10174/2013 filed earlier. But then these writ petitions were dismissed as withdrawn on 11.11.2014. Nothing prevents the first respondent Bank from surging ahead with Ext.P4 notification. Ext.P4 notification invites applications for appointment to the post of Peon, Attender, Night Watchman etc. in the first respondent Bank. It is reported that written test and interview was also conducted. Ext.P4 notification was issued much prior to the amendment of the Rules prescribing maximum qualification. Therefore the proceedings shall continue as per the unamended Rules and the appointment effected soon. The needful shall be done within a period of two months from the date of production of a copy of this judgment.

The writ Petition is disposed of.
