JUDGMENT

Petitioners are working as Lower Division Clerk in the Kerala State Beverages (Manufacturing and Marketing) Corporation Ltd. Petitioners grievance is that after completion of the period of probation, their probation is yet to be declared. Petitioners further submitted that there are vacancies in the next higher post of Assistant Grade II. On account of non-declaration of their probation, petitioners are not considered for promotion. Petitioners made Ext.P8 to P13 representations before the first respondent. Petitioners approached this Court on account of non-consideration of their representations and to consider them for promotion to the next higher post of Assistant Grade II.

2. In view of pendency of Exts.P8 to P13, there shall be a direction to the first respondent to consider Exts.P8 to P13 representations within a period of six weeks after hearing any of the petitioners.

The Writ Petition is disposed of.
