J U D G M E N T

The petitioner, the owner of stage carriage No. KL-13/J-9978 applied for temporary permit on the route Mundathode - Thalassery - Idumba - Thrikaderipoil in the vacancy of stage carriage No. KL-13/T-4950. The petitioner has approached this Court with a prayer to direct the respondent to grant and re-issue temporary permit to the petitioner's stage carriage No. KL-13/J-9978 on the route Mundathode - Thalassery - Idumba - Thrikaderipoil in the vacant timings of stage carriage bearing No. KL-13/T-4950.

2. If vacancy of stage carriage bearing registration No. KL-13/T-4950 is still in existence and no other person having better claim has applied for a temporary permit to operate a stage carriage in that vacancy, there will be a direction to the respondent to consider re-issuance of a temporary permit of four months

duration within one week from the date of production of a copy of this judgment by passing appropriate orders on Ext.P3. Needless to say, such issuance of temporary permit will be subject to the preferential claim if any.
