JUDGMENT

The petitioner has approached this Court challenging the action taken by the respondent Bank for recovery of amounts granted to him by way of loan.

2. When the matter came up for admission, it was noticed that the husband of the petitioner had already approached this Court on an earlier occasion and by Ext.P5 judgment, the husband of the petitioner was granted an opportunity for repaying the amount in installments.

3. In the present writ petition, the petitioner also seeks identical reliefs. On noticing Ext.P5 judgment, I had directed the petitioner to take steps to file a review petition against Ext.P5 judgment and in order to enable her to do so, I had granted an interim stay, initially for a week and thereafter further extended , so as to enable the petitioner to file a review petition before this Court.

When the matter was called up today, it is reported that a review petition has since been filed by the husband of the petitioner and the same has been numbered. Taking note of this submission, I dismiss this writ petition as not maintainable.
