JUDGMENT

The petitioner was appointed as LPSA in an aided school with effect from 2.6.2014. The petitioner submits that the approval of appointment has been declined by the Assistant Educational Officer stating that the post is not available under 1:45 teacher students ratio. Ext.P3 is the order passed by the Assistant Educational Officer dated 16.9.2014. Challenging Ext.P3, the petitioner preferred Ext.P4 appeal before the District Educational Officer.

In view of the above, there shall be a direction to the second respondent to consider and pass appropriate orders on Ext.P4 after hearing the petitioner within a period of two months from the date of receipt of a copy of this judgment.

The writ petition is disposed of as above.
