J U D G M E N T

The petitioner has approached this Court with a prayer to direct the respondent to grant and issue temporary permit to the petitioner's stage carriage No. KL-57/K-8019 on the route Narikkunni - Kozhikode in the vacant timings of stage carriage bearing No. KL-57/9542.

2. If vacancy of stage carriage bearing registration No. KL-57/9542 is still in existence and no other person having better claim has applied for a temporary permit to operate a stage carriage in that vacancy, there will be a direction to the respondent to expeditiously consider the temporary permit of four months
