J U D G M E N T

The petitioner in the above writ petition is a regular stage carriage permit holder operating vehicle bearing registration No. KL-9/N-9764 in the route Pathiripala - Palakkad - Walayar. The timings of the service was last allotted on 04.11.1994, hence the petitioner filed an application to revise the timings by Ext.P6 dated 29.12.2014. The petitioner prays for an expeditious consideration of his application.
