The retrospective hike in pole rental is challenged by the petitioner by filing Ext.P3 representation. The dispute requires to be resolved by the third respondent as per clause 9 of Ext.P1 agreement.

The needful shall be done within a period of two months from the date of production of a copy of this judgment. The coercive steps as against the petitioner shall be put on hold in the meanwhile. This is subject to the condition that the petitioner clears the arrears as per the pre-revised rate.
