Heard the learned counsel for the petitioner.

2. This Writ Petition has been filed seeking a direction to respondents 1 to 3 to afford adequate police protection to the life and liberty of the petitioner, her husband Mahroof and his family members from the threat or force from the 4th respondent. 4th respondent is none other than the father of the petitioner. Petitioner claims to have converted into Islam and married one Maharoof V.K. A habeas corpus petition has already been filed by the father of the petitioner before this Court which is pending

consideration.
