J U D G M E N T

The petitioner is aggrieved with the non-issuance of regular permit granted on 12.11.2014. When timings were not settled for two months, the petitioner filed an application for temporary permit, which is evidenced at Ext.P2. The petitioner prays that timing conference be convened expeditiously and timings settled and in the meanwhile, temporary permit be issued on the proposed set of timings.

2.
