JUDGMENT

The petitioner in the above writ petition is a regular stage carriage permit holder operating vehicle bearing registration No. KL-58/M-9123 in the route Mandankavu-Thalassery-Vadakkumbad HS-Mahepalam. The timings of the service was last allotted on 13.9.2007, hence the petitioner filed an application to revise the timings by Ext.P1 dated 31.12.2014.
