JUDGMENT

The petitioners confine their relief to easy instalments to repay the amount due to the second respondent bank and to defer the coercive steps in the meanwhile.

2. I permit the petitioners to pay the amount due in ten equal monthly instalments starting from 02.03.2015. The coercive steps pursuant to Exts. P1 to P3 notices shall be put on hold if the petitioners comply with the conditions in time. The coercive steps shall surge ahead if the petitioners commit default in the payment of any one of the instalments as directed.
