**JUDGMENT**

Unconnected fixed charges demanded from the petitioner to the tune of ₹1,86,129/- is impugned. The petitioner has an effective remedy under clause 130(8) of the Kerala Electricity Supply Code, 2014.

2. Any motion made within three weeks from today shall be dealt with by the Consumer Grievance Redressal Forum within two months therefrom. The coercive steps as against the petitioner shall be put on hold if a sum of ₹85,000/- (Rupees Eighty five thousand only) is remitted within a period of one month.

3. It is however clarified that the petitioner has to pay the current charges and clear the monthly bills.

The Writ Petition is disposed of.
