Ashok Bhushan, Ag.C.J.

This writ petition has been filed by the petitioner alleging police harassment and seeking a direction to Respondents Nos.1 to 3 not to harass the petitioner and also not to compel the petitioner to withdraw the case numbered as C.M.P No.7926/2014 in the Court of J.F.C.M., Vatakara.

2. The learned Senior Government Pleader, after obtaining instructions, submitted that a complaint was received and in respect of the same, a crime has already been registered as Crime No.19/2015. Since a crime has already been registered, we do not see any police harassment in the facts of the case. It is open for the petitioner to take such steps in accordance with law.
