J U D G M E N T

The petitioner has approached this Court with the following prayers:

- “(a) Direct the first Respondent to consider the Petitioner's Application SM No.2802/2013 for issuance of Purchase Certificate in respect of 40 cents of land in Sy.No.61 of Anakkara Village and pass orders on merit within a specified period;*
- (b) Grant such other reliefs as this Hon'ble Court may deem fit and proper in the facts and circumstances of the case.”*
